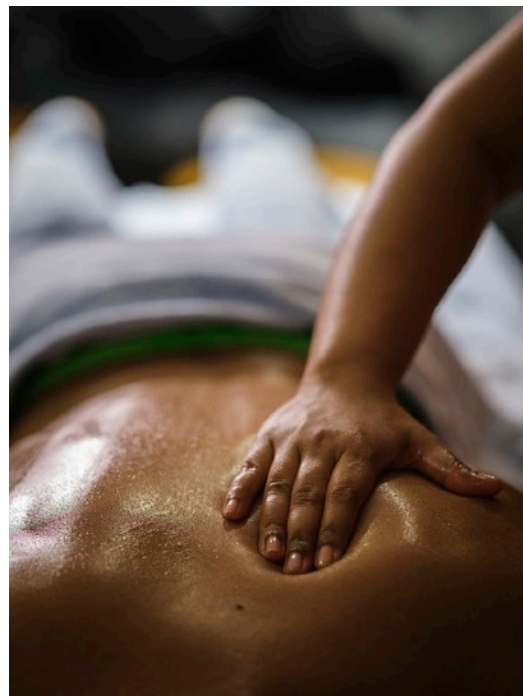

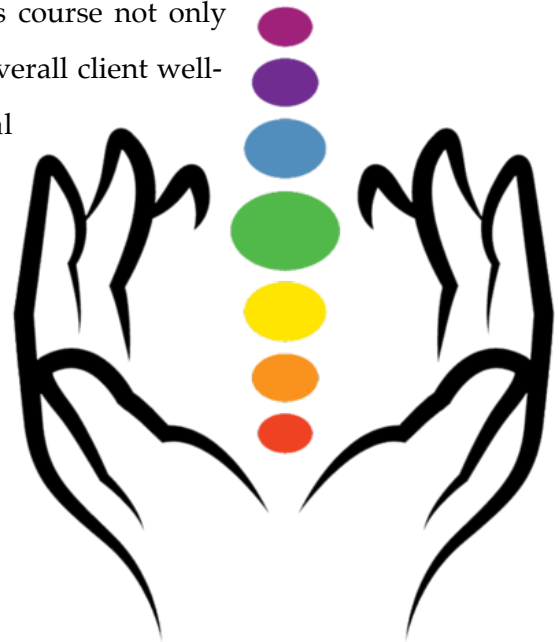
## Massage Related Courses

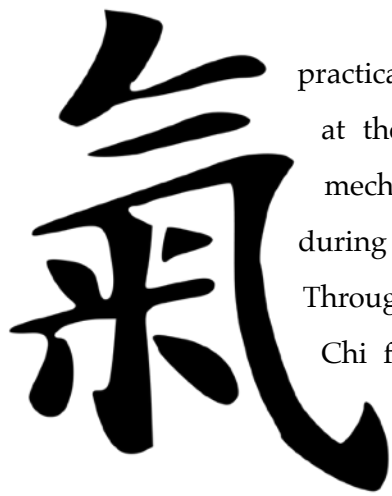

## Admissions

All applicants must:

- Be at least 18 years of age
- Be physically and emotionally capable of performing and receiving massage with both males and females
- Display a philosophy, professional attitude and maturity compatible with NC Massage School objectives and professional standards
- Have graduated from high school or have completed a GED
- If applicable, provide documentation of probation, felony or misdemeanor charges and conviction.

At NC Massage School, we believe in providing a comprehensive and cohesive learning experience, ensuring that all students receive the full depth of our curriculum, instructional methods, and hands-on training. Because our program is uniquely designed to integrate foundational knowledge with progressive skill development, we do not accept transfer credit, as every course and clinical experience is essential to maintaining the integrity and quality of our education.



# School Visitation

We welcome prospective students to make an appointment with admissions for an interview and tour of the school. During this time students will meet some of the staff, tour the facility, perhaps view classes in session, and discuss entrance into the school.

## Admissions Procedure

- Complete the “Register Now” form online and you will receive an email with a custom link to our MyPath Online Registration Site. Complete the MyPath forms with all requested documentation and submit along with the non-refundable application fee.
- Be familiar with the contents of this catalog.
- Once your application is received, you will be contacted to schedule an appointment for a personal interview.
- Notification of acceptance or denial is sent within thirty days of completion of the application process. Once accepted, applicants will need to send a non-refundable tuition deposit to ensure a place in the program.

## Denial of Admission

This institution reserves the right to deny admission to any applicant for reasons including, but not limited to:

- Failing to meet the stated entrance requirements
- Lacking the physical capacity to perform massage
- Having a health problem that interferes with duties as a student or massage practitioner
- Being unable to meet financial obligations to the school
- Exhibiting a lack of motivation, or an incompatible bodywork philosophy

Our school is committed to providing an exceptional educational experience. Your admission may be denied if you require specific specialized instruction that we are unable to accommodate.

The School may deny an applicant if it is deemed that an education in massage is not beneficial to the individual. In the event an applicant is denied admission, the decision is final and may not be appealed.

## Class Size

Highly personal training is our approach. Theory class size is limited to a maximum of 18 students. Student teacher ratio during hands on classes is 8 to 1. At NC Massage School, you will be taught only by highly trained and skilled instructors. This provides for an optimum learning environment second only to private tutoring.

## Continuing Education

NC Massage School offers opportunities for continually developing and improving therapeutic massage and bodywork skills. We are designated as an Approved provider for Continuing Education by the National Certification Board for Therapeutic Massage & Bodywork (NCBTMB).

## Attendance Policy

Attendance is mandatory at all classes and clinics during the enrollment in our seven hundred (700) hour massage therapy program. Attendance and punctuality are part of responsible and professional behavior. All grade criteria for individual courses require a component of attendance. **Students must attend 100% of the Supervised Clinical Internship.**

- For a student to receive credit in a course, the student shall attend 80 percent of the instructional hours of the course. The student shall also make up missed instructional hours to equal no less than 98 percent of the instructional hours in the course according to the procedures established by the school. SECTION .0600 - MASSAGE AND BODYWORK THERAPY SCHOOLS, 21 NCAC 30 .0620 (11) BMBT

- Students clock in at the beginning of each day. If a student arrives over five minutes late four times for any given day, or departs more than 30 minutes early, it will be considered as one days absence.

- The school will officially terminate a student who has unexcused absences for five consecutive school calendar days.

## Leave of Absence Policy

A leave of absence may be granted only at the discretion of the Program Director.

- Requests for a leave of absence must be made in writing to NC Massage School PRIOR to the missed classes or WITHIN THE FIRST WEEK OF ABSENCE when an unexpected personal emergency occurs.

- A leave of absence of up to four successive weeks may be granted by NC Massage School which cannot take place prior to the first supervised internship or during any of the four supervised internship weeks.

- The student must make up any missed exams within two weeks of his/her return.

- If a leave of absence exceeds four weeks, for financial aid and tuition calculation purposes, it will be treated as a withdrawal from the program.

## Make-up Work Policy

Make-up work is the responsibility of the student, and is allowed for approved situations. If a student is not present for a class, an absence is entered into the attendance record. The student is expected to contact NC Massage School as soon as possible regarding an absence. Make-up work must be completed within five calendar days. Make-up/re-take tests must be completed within three school days. To make up missed work, a student must:

- Obtain the form NC Massage School Make-up Work Contract and contact instructor.
- Complete form according to directions given by instructor and present form with made-up work on each class missed to appropriate instructor on return to school.
- Hands-on class work has a make-up fee for instruction time.
- Re-testing fee is to be paid prior to taking the exam/quiz.
- Final exams and/or evaluations incur a re-test fee.
- Under no circumstances may any exam be repeated more than once.
- No more than five total retakes will be allowed during a student's enrollment.
- Students must call 24 hours in advance to guarantee an appointment for a written exam.

Make-up exams will be scheduled outside of classroom hours.

No diploma will be granted until all course requirements are met. Additional costs may be incurred during this make-up process.

## Tutoring Policy

Tutoring for students in need of additional help is available from appropriate instructors at a charge per hour for lecture and per hour for hands-on classwork. All tutorial fees are paid directly by the student to the instructor. Student tutorial needs are based on notification by students to instructor, from the Director, or by substandard performance. Tutorial services can be used for make-up in special circumstances, determined by the instructors or other appropriate staff.

## Incomplete Policy

Incomplete grades are granted only in exceptional cases, and are considered on a case-by-case basis. The instructor and student will create a contract, with deadlines recorded. If the student fails to complete the work by the deadline, he/she will receive a failing grade and the course must be retaken.



# Satisfactory Progress

In order to maintain satisfactory progress toward a NC Massage School diploma, students are required to:

- Maintain, in all courses, a minimum grade point average of 70% in a 100-point system.

90 - 100	A
80 - 89	B
70 - 79	C
Below 70	Fail

- Complete the program in the time frame for which they have enrolled.
- Complete all 100 clock hours of the Supervised Clinical Internship course.
- Complete the minimum of clock hours required in all other courses.
- Participate in class activities including giving and receiving massage.
- Throughout the program bring required textbooks, as listed in each course syllabus and be prepared.
- Document the required hours of practice massage sessions during the program.
- Receive and document 3 professional massage sessions during the program.

## Probation and Dismissal Policy

Probation is a disciplinary action that addresses specific rule violations by monitoring students performance for a specified time period while allowing the student to attend classes. Students will be informed in writing, as well as by speaking with the Director of Education, of probation and criteria of probation. The maximum length of time a student may be put on probation is 30 days. At the end of the probationary period, the student will meet with the staff to determine if he/she has complied with the criteria of probation. If the criteria has been satisfactorily met, probationary status will be dropped. If the student has not satisfactorily complied with the criteria of the probation, the student may be dismissed from the program. A student may be placed on probation for failure to adhere to all policies in this catalog which may include but not limited to:

- follow Student Code of Ethics and attendance policy

- meet satisfactory academic progress
- meet up-to-date tuition payments
- have a complete student file
- follow student dress code

Dismissal indicates that a student must withdraw from the school program and may not reapply for at least one year or more, as determined by the Director of Education and Program Director. A student may be dismissed for:

- failure to complete probationary requirements
- grave violations of the Student Code of Ethics
- failure to make tuition payments up-to-date
- continuation of behavior leading to probation

## USERRA Compliance

ABSENCE FOR MILITARY SERVICE PURPOSE: NC Massage School is committed to full compliance with statutory requirements pertaining to employees and students who are absent from work due to military service. This policy provides general information and guidance concerning management's and military employees' respective rights and responsibilities in dealing with such absence(s). Additionally, the policy references revisions to other administrative policies related to employees who are absent due to military service.

POLICY: A. UNIFORMED SERVICES EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT (USERRA) As an employer and school, NC Massage School will comply with its obligations as described under the Uniformed Services Employment and Reemployment Rights Act (USERRA), the federal statute that governs the terms and conditions of military employees and students who are absent from work. Employees and students in the military services are expected to likewise comply with the responsibilities and terms and conditions set forth in the statute. For a specific detailed listing of the legal requirements, the USERRA statute should be referenced. However, for purposes of this policy, an employee's key rights and responsibilities include:

- An employee/student who receives notice to report for active military service must provide and submit authentic military orders for deployment to the proper management personnel as well as comply with all notification requirements of USERRA.
- An employee/student upon submittal of the necessary military orders is automatically excused from work during the absent time proscribed in the military orders; such absent periods shall be permitted up to a maximum 5-year lifetime limit as designated in USERRA.
- An employee/student on absent time while serving in the military shall be entitled to the same rights, benefits, etc. for which they are qualified to receive like other employees/students working for the employer.

## Grievances

The faculty and staff at NC Massage School are committed to hearing and resolving school-related problems or concerns. We believe that student feedback is essential to the continuing growth and development of our program. We will provide you with a list of faculty and staff members so you may address your concerns to the appropriate person.

If you are dissatisfied with the results, please put your concerns in writing and submit it to the Director of Education, who will meet with other appropriate parties to address the issue. You will receive a response within 10 calendar days. In the unlikely event of an irresolvable complaint, it is possible for the matter to be carried to the N.C. Board of Massage & Bodywork Therapy, but only after every effort has been made to resolve the problem at NC Massage School.

# Graduation Requirements

To be awarded a diploma from NC Massage School, students must meet the following graduation requirements:

- Successfully fulfill all academic and attendance standards as outlined in the Satisfactory Progress and Attendance Policy.
- Adhere to all school rules and regulations, including maintaining professional conduct and ethical standards at all times.
- Ensure that all tuition and fees are paid in full or have an approved payment plan in place.
- Complete all coursework, clinical requirements, and practical assessments, including the final massage practical, which must be completed no later than two weeks prior to the scheduled graduation date.

Students who have not met these requirements may not participate in the official graduation ceremony until all obligations are fulfilled. However, students are eligible to participate in the graduation ceremony.

Upon successful completion of the program, graduates will receive a diploma in Therapeutic Massage and Bodywork and a certificate in Neuromuscular Therapy, signifying their completion and professional certification.

## Licensure Requirements

North Carolina requires massage therapists and bodyworkers to be state licensed before they have the right to practice.

North Carolina requires graduates to pass the MBLEx exam as part of their application process. NC Massage School graduates are completely prepared to pass the exam.

Once a graduate successfully completes the MBLEx exam, they may then apply for state license.

# Student Code of Ethics

Positive ethical behavior is expected of all students enrolled in NC Massage School program. Students must follow all school policies, which include but are not limited to:

- Students must dress appropriately while attending classes, following NC Massage School Student Dress Policy.
- Students must follow Attendance Policy.
- Students may not engage in any sexual activity on the campus.
- Sexual harassment or innuendoes are not allowable at any time at NC Massage School.
- Students must maintain acceptable personal hygiene.
- Smoking is not allowed inside the school building or on school grounds.
- Students may not violate the Substance Abuse Policy.
- Students must use professional draping procedures in all massage classes and clinics.
- Students may not cheat on exams or homework, or plagiarize
- Students may not be disruptive in classrooms or on school grounds and must treat instructors and fellow students with respect
- Students use of NC Massage School credentials and/or name before all graduation requirements are met is prohibited unless approved by the appropriate administrative staff.
- Students must respect the property of NC Massage School and obtain permission before using or taking any property owned by NC Massage School or by school personnel.
- Students must honor privacy and confidentiality of massage recipients, both student and public.
- Students must work with clinic clients in a professional and ethical manner and comply with all policies concerning the clinic experience.
- Physical/verbal abuse is prohibited towards any instructor, staff member or student.
- Students must follow the Infectious Conditions Policy.
- Classroom behavior that could cause public comment that is detrimental to the profession is prohibited.
- Solicitation is not allowed at NC Massage School, either on school property or at any school-sponsored events.



# Withdrawal Policy

Any applicant, withdrawing before or after acceptance to the program, must notify in writing his/her intent to the Administrator in a timely manner. After receipt of intention to withdraw, NC Massage School will forward a Withdrawal Form to be completed, signed and returned to the school. NC Massage School has 15 days to complete the withdrawal process after receipt of the Withdrawal Form. The result may mean a refund to the student or additional monies owed to the school. The following policy is designed to calculate the percentages for the withdrawal process.

- **Termination Date:** The termination date for refund computation purposes is the last date of actual attendance by the student.
- **Rejection:** An applicant rejected by the school shall be entitled to a refund of monies paid with the exception of the application fee and tuition deposit.
- **Student Dismissal:** For a dismissed student, refunded tuition will follow the same guidelines as for those students who withdraw.
- **Right to Cancel:** The applicant or student has the right to cancel and withdraw from the program at any time following the guidelines of the refund policy and enrollment contract
- **Three-day Cancellation:** All monies paid by the applicant will be refunded if requested within three business days after signing an enrollment contract and making initial payment with the exception of the application fee, and tuition deposit.
- **Student Withdrawal:** Any applicant subsequently requesting cancellation before entering school and starting the course, after signing the enrollment contract, and after three-day cancellation period, shall be entitled to a refund of all monies paid, less the tuition deposit and application fees.

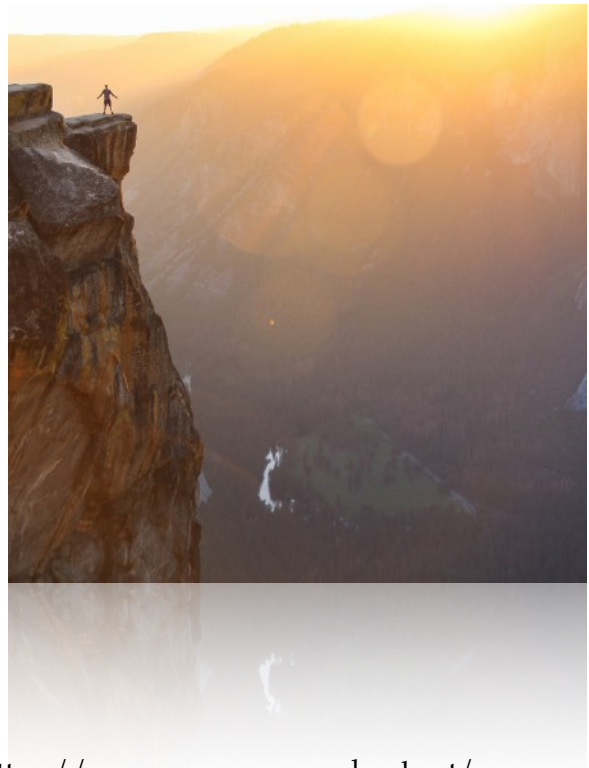
## Refunds

- For a student completing up to 5%, the tuition charge will be 5% of the contract price plus the tuition deposit and application fee.
- For a student completing more than 5% but no more than 10%, the tuition charge will be 20% of the contract price plus the tuition deposit and application fee.

- For a student completing more than 10% but no more than 25%, the tuition charge will be 50% of the contract price plus the tuition deposit and application fee.
- For a student completing more than 25% the student is responsible for 100% of the contract price. All unpaid payments will be paid to the school on pre-planned dates as contracted by the student.

## Job Placement

NC Massage School supports graduates by passing along referrals on any job opportunities that become known to the school. NC Massage School encourages a variety of experiences and is aware that there are no guarantees of profitable employment. Therefore, we develop relationships with other local businesses and health care providers to provide students with many job opportunities. In addition, all NC Massage School students graduate with business skills to help them develop their own practice or find work, i.e., public speaking, knowledge of massage, professional organization, etc. NC Massage School has a record of past, present and potential employers to which students and graduates may have access. Since there is no saturation of Massage Therapists, the vast majority of our graduates are able to find work within the field. Jobs vary widely from health spas, salons, cruise ships, fitness gyms, chiropractic offices, nursing homes, and pain management clinics to professional and amateur athletic sport teams. Many health professionals are incorporating their medical backgrounds with Massage. A high percentage of NC Massage School graduates are in full-time, private practice; others have chosen a part-time career.
