COURSE DESCRIPTIONS

Science and Muscle Courses

Anatomy and Physiology

This course provides study of the basic structure and function of the body's major systems. Students are provided with a detailed study of the structure and functions of the integumentary, skeletal, muscular, nervous, cardiovascular, lymphatic/immune, respiratory, digestive, urinary, and reproductive systems of the body. Emphasis will be placed on skeletal, muscular, and nervous systems as they relate to massage therapy. Effects of specific massage techniques on these systems are integrated to reinforce the necessity and relevance of this information. Visual aids, models, and hands-on materials support student learning.

Pathology

Pathology is the study of disease. In this course the students will gain a basic understanding of the concepts of disease, inflammatory response, client assessments, therapeutic evaluation, and when to refer. Common pathologies associated with each of the major systems of the body are outlined with special emphasis on the integumentary, musculoskeletal, nervous, and circulatory systems. Cross referencing of pathology information with physiological effects of massage allows students to effectively determine massage treatment place and to identify the most appropriate applications or modality for their clients.



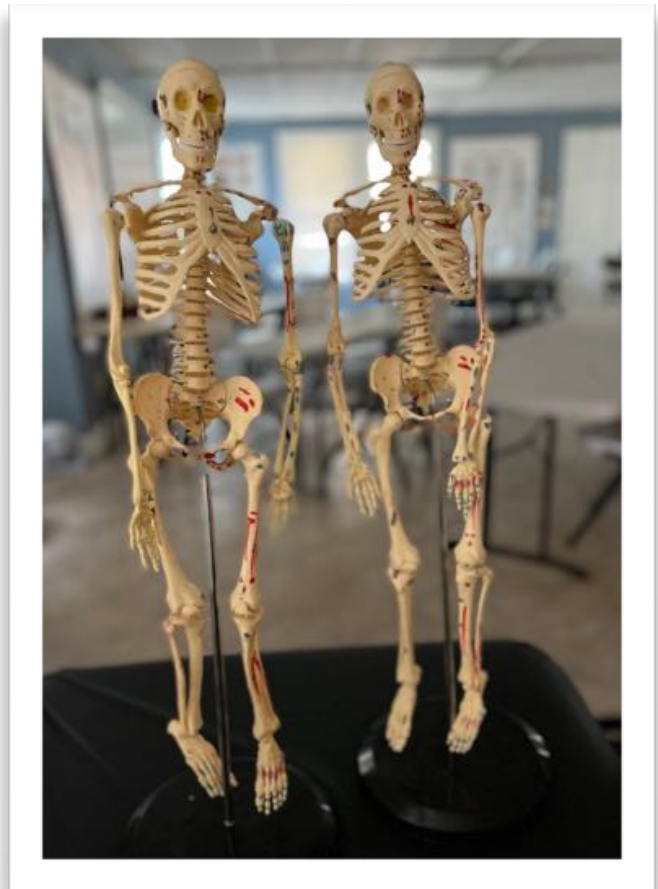
Kinesiology

This course provides in-depth study of the structure and function of the musculoskeletal systems as it relates to movement, posture, health and massage.

Manikin® Muscles - Musculoskeletal Anatomy

Developed by Jon Zahourek Systems®, Maniken® class gives students the opportunity to build muscles of the extremities with clay on a skeletal model. This provides the student with a three dimensional, kinesthetic learning process for understanding muscles. Besides giving a review of the skeletal structure, Maniken® muscles help the student to perceive the relationship of one muscle to another in terms of depth, superficiality and attachments.

Students will be able to identify over 100 muscles, their origins and insertions and actions, as well as all bones and major bony landmarks. Students are taught to palpate thoroughly every structure presented in this course.



Massage and Related Courses

Swedish Massage

This course is the core of the massage therapy program. Students will become competent in techniques and learn theory, contraindications, therapeutic benefits, effects, and history of Swedish massage in relationship to manipulative therapies. The five basic strokes: effleurage, petrissage, friction, vibration, and tapotement will be taught. Students will learn to develop a full body routine utilizing this universally recognized modality.

Supervised Clinical Internship

Open to the public, the internship provides students with a supervised setting to refine massage skills and develop the business and professional skill necessary for a successful massage career. Students gain experience and improve skills in operation, communications and decision-making procedures that occur in a professional massage setting. The L.M.B.T. supervising the clinic provides support and guidance, assess, and if necessary, correct performance while students complete their massage and assigned tasks.

Note: .0626 Student Compensation Prohibited. A student shall not receive a fee, tip or other consideration for the massage and bodywork therapy they perform while completing clinical requirements for graduation, whether or not the school charges a fee for services provided in a student clinic.

Neuromuscular Therapy and Certification Option

This advanced course is also an optional certification program for those who pass the final palpatory exam with a grade of 90 or higher. Neuromuscular Therapy (NMT) includes the application of rehabilitative techniques to treat chronic pain produced by Myofascial Pain Syndrome (MPS) and muscular dysfunction from injury. The foundation of this class is the lifelong achievement in research by Janet Travel, M.D.,

and David Simons, M.D., on MPS, incorporating the effective treatment techniques they have developed and subsequent work done by other leading NMT practitioners in the field. NMT umbrella techniques are trigger point therapy, contract/relax, myofascial release, deep transverse friction, postural release, stretching and patient education. Students will identify when to effectively treat with NMT techniques, communicate effectively and appropriately with clients about possible treatment options and self-care, and be able to demonstrate basic NMT techniques.

Postural Assessment


Students will learn how to use visual cues in assessing client's postural holding patterns. Students will participate in gait analysis and differentiate through active and passive range of motion testing holding patterns. This is a practical participation class that links Swedish, Kinesiology, and Neuromuscular Courses.

Video Mechanics

This is a support arm of all table technique classes. It is a visual component that enables students to actually see themselves practice massage.

Body Mechanics

Students will learn the importance of proper positioning of their body to increase effectiveness while administering massage. The ability to correctly apply force, as well as mechanical factors which will reduce fatigue will be addressed.

Tai Chi



Tai Chi is an ancient, Oriental system of movement and energy development. It is helpful in maintaining better breathing, joint flexibility, and body posture. Students will experience the principles and application of Tai Chi Chuan and other exercises for body and mind centering. Practicing Tai Chi principles at the massage table will aid the student by encouraging effective and efficient movement during the therapy session. Tai Chi greatly enhances Western body mechanics and allows a massage therapist to experience fewer injuries and more energy in their chosen profession .

Acupressure

Acupressure is an ancient form of bodywork developed in China over 2000 years ago. According to Chinese medical theory, finger pressure applied to acupuncture points (tsubo) helps maintain a flow of energy (Qi) in channels called meridians to maintain and restore health. Students will develop an understanding of the five element theory, the concept of yin/yang, the 14 traditional meridians, and important acupressure points. Students learn to incorporate acupressure techniques into a massage session to enhance a client's well-being. This course greatly enhances Neuromuscular Trigger Point Therapy.

Hydrotherapy

Hydrotherapy is the use of water in solid, liquid or gaseous form. Students will experience and learn to apply water, ice therapies, and moist heat therapies appropriately. Students will learn the appropriate modality in specific therapeutic situations by understanding the thermodynamics of heat and cold on body tissues and function.

Practice Building Courses

Professional Development

This course prepares students for employment in professional clinical practices and to be successful entrepreneurs. Detailed segments addressing professionalism, self-care, communications, marketing, record keeping, resume writing, interview skills and business skills necessary for the successful operation of a professional massage business are presented.

Students explore topics such as: effective communication skills, identification of various disruptive and addictive behaviors, physical manifestations of emotional and psychological holding, body mind connection, stress management, confidentiality, licensing information, office set-up, client management, billing procedures, basic accounting, and tax requirements.

Somatic Psychology

Life is more fulfilling and satisfying if we live with honor and integrity in all our relationships and business dealings, yet much confusion exists amongst practitioners about what is and what is not ethical behavior. This confusion can be even more complex for somatic practitioners.

This course assists students in the ability to listen to their clients bodies and hear their thoughts and feelings without reacting emotionally, but rationally and professionally. This course encourages the student to reflect upon their reactions to any situation and to ensure that the experience is a fiduciary one for the client.

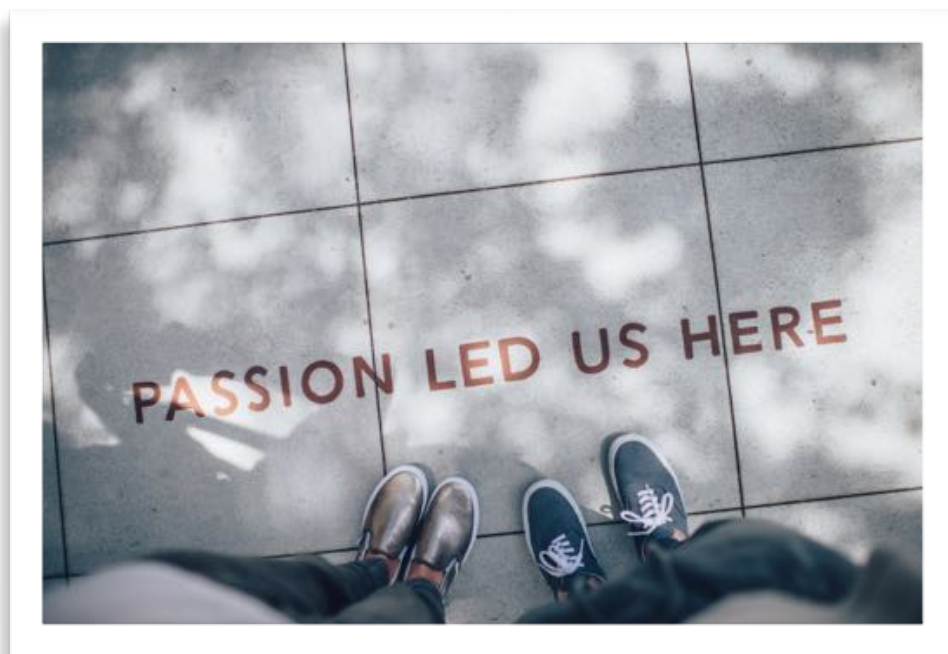
Ethics

"Ethics is the process by which we sort out what best creates inner and outer harmony in our lives." Kylea Taylor, *The Ethics of Caring*. Classes include lecture on the philosophy and science of ethics and its relationship to Massage Therapy, clients, and other health professionals. N.C. laws and rules for the practice of massage are

also discussed. Group participation includes solving ethical dilemmas and presenting "answers" for further discussion to the entire class. Students will be able to define ethics, and will explore a variety of codes of ethics from the field of Massage Therapy .

Business Panel

The business panel is composed of visiting Massage Therapists and guest speakers who represent their experiences to the students. A moderator keeps the discussion rolling and prepares a set of possible questions and scenarios for the group to discuss. This class gives the student the opportunity to listen and to question experienced Massage Therapists who have different target markets and a variety of practices in the field of massage therapy and bodywork

ADMISSIONS

All applicants must:

- Be at least 18 years of age by start date
- Be physically and emotionally capable of performing and receiving massage with both males and females
- Display a philosophy, professional attitude and maturity compatible with NC Massage School objectives and professional standards
- Have graduated from high school or have completed a GED
- If applicable, provide documentation of probation, felony or misdemeanor charges and conviction.
- Must receive a professional massage by a certified Neuromuscular therapist (within the previous six months)

School Visitation

We welcome prospective students to make an appointment with admissions for an interview and tour of the school. During this time students will meet some of the staff, tour the facility, perhaps view classes in session, and discuss entrance into the school.

Admissions Procedure

- Complete the application found in the bulletin or online and submit it with all requested documentation and non-refundable application fee.
- Be familiar with the contents of this catalog.
- Once your application is received, you will be contacted to schedule an appointment for a personal interview.

- Notification of acceptance or denial is sent within thirty days of completion of the application process. Once accepted, applicants will need to send a non-refundable tuition deposit to ensure a place in the program.

Denial of Admission

This institution reserves the right to deny admission to any applicant for reasons including, but not limited to:

- Failing to meet the stated entrance requirements
- Lacking the physical capacity to perform massage
- Having a health problem that interferes with duties as a student or massage practitioner
- Being unable to meet financial obligations to the school
- Exhibiting a lack of motivation, or an incompatible bodywork philosophy

The School may deny an applicant if it is deemed that an education in massage is not beneficial to the individual. In the event an applicant is denied admission, the decision is final and may not be appealed.

Tuition, fees and other others schedules along with various payment options can be found in our annual bulletin.

Class Size

Highly personal training is our approach. Theory class size is limited to a maximum of 18 students. Student teacher ratio during hands on classes is 8 to 1. At NC Massage School, you will be taught only by highly trained and skilled instructors. This provides for an optimum learning environment second only to private tutoring.

Transfer of Credit Policy

NC Massage School may accept transfer credit for courses taken only at other N.C. State approved massage programs, provided that the syllabus of the transferable class is in accord of that of the NC Massage School class in question. Before credits can be accepted as transferred, the student is required to pass an appropriate class examination designed by the instructor of the course in question. The number of contact hours of the transfer course must meet or exceed the number of hours of the course offered by NC Massage School. A transcript stating the number of hours successfully completed must be provided from the school at which the course was taken. Should hours be shortened by a transfer of credit, there may be a cost reduction in the program with the approval of the Program Director. A non-refundable fee is due before taking the required exam. Any transfer of credit must be completed prior to start of the class. No one is allowed to test out once the class has started. No refunds are given for transfer credit. All other classes must be taken in their entirety.

Auditing

Auditing is available to students for making up and repeating classes as well as to graduates of NC Massage School. Auditors will be assigned to class on a space available basis at the discretion of the school.

Continuing Education

NC Massage School offers opportunities for continually developing and improving therapeutic massage and bodywork skills.

We are designated as an Approved provider for Continuing Education by the National Certification Board for Therapeutic Massage & Bodywork (NCBTMB).

POLICIES

Leave of Absence Policy

A leave of absence may be granted only at the discretion of the Program Director.

- Requests for a leave of absence must be made in writing to NC Massage School PRIOR to the missed classes or WITHIN THE FIRST WEEK OF ABSENCE when an unexpected personal emergency occurs.
- A leave of absence of up to four successive weeks may be granted by NC Massage School.
- The student must make up any missed exams within two weeks of his/her return.
- If a leave of absence exceeds four weeks, for financial aid and tuition calculation purposes, it will be treated as a withdrawal from the program.

Make-up Work Policy

Make-up work is the responsibility of the student, and is allowed for approved situations. If a student is not present for a class, an absence is entered into the attendance record. The student is expected to contact NC Massage School as soon as possible regarding an absence. Make-up work must be completed within ten calendar days. Make-up/re-take tests must be completed within three school days. To make up missed work, a student must:

- Obtain the form NC Massage School Make-up Work Contract and contact instructor.

- Complete form according to directions given by instructor and present form with made-up work on each class missed to appropriate instructor on return to school.
- Hands-on class work has a make-up fee for instruction time.
- Re-testing fee is to be paid prior to taking the exam/quiz.
- Final exams and/or evaluations incur a re-test fee.
- Under no circumstances may any exam be repeated more than once.
- No more than five total retakes will be allowed during a student's enrollment.
- Students must call 24 hours in advance to guarantee an appointment for a written exam. Make-up exams will be scheduled outside of classroom hours.

No diploma will be granted until all course requirements are met. Additional costs may be incurred during this make-up process.

Tutoring Policy

Tutoring for students in need of additional help is available from appropriate instructors at a charge per hour for lecture and per hour for hands-on classwork. All tutorial fees are paid directly by the student to the instructor. Student tutorial needs are based on notification by students to instructor, from the Director, or by substandard performance. Tutorial services can be used for make-up in special circumstances, determined by the instructors or other appropriate staff

Work Policy

Incomplete Policy

Incomplete grades are granted only in exceptional cases, and are considered on a case-by-case basis. The instructor and student will create a contract, with deadlines recorded. If the student fails to complete the work by the deadline, he/she will receive a failing grade and the course must be retaken.

Satisfactory Progress

In order to maintain satisfactory progress toward a NC Massage School diploma, students are required to:

- Maintain, in all courses, a minimum grade point average of 70% in a 100-point system.

80 – 89	B
70 – 79	C
Below 70	Fail

- Complete the program in the time frame for which they have enrolled.
- Complete all 100 clock hours of the Supervised Clinical Internship course.
- Complete the minimum of clock hours required in all other courses.
- Participate in class activities including giving and receiving massage.
- Throughout the program bring required textbooks, as listed in each course syllabus and be prepared.
- Document the required hours of practice massage sessions during the program.
- Receive and document 3 professional massage sessions during the program.

Probation and Dismissal Policy

Probation is a disciplinary action that addresses specific rule violations by monitoring students performance for a specified time period while allowing the student to attend classes. Students will be informed in writing, as well as by speaking with the Administrator, of probation and criteria of probation. The maximum length of time a student may be put on probation is 30 days. At the end of the probationary period, the student will meet with the Administrator to determine if he/she has complied with the criteria of probation. If the criteria has been satisfactorily met, probationary status will be dropped. If the student has not satisfactorily complied with the criteria of the probation, the student may be dismissed from the program. A student may be placed on probation for failure to adhere to all policies in this catalog which may include but not limited to:

- follow Student Code of Ethics and attendance policy
- meet satisfactory academic progress
- meet up-to-date tuition payments
- have a complete student file
- Follow student dress code

Dismissal indicates that a student must withdraw from the school program and may not reapply for at least one year or more, as determined by the Administrator and Director. A student may be dismissed for:

- failure to complete probationary requirements
- grave violations of the Student Code of Ethics
- failure to make tuition payments up-to-date
- continuation of behavior leading to probation

Grievances

The faculty and staff at NC Massage School are committed to hearing and resolving school-related problems or concerns. We believe that student feedback is essential to the continuing growth and development of our program. We will provide you with a list of faculty and staff members so you may address your concerns to the appropriate person.

If you are dissatisfied with the results, please put your concerns in writing and submit it to the Administrator, who will meet with other appropriate parties to address the issue. You will receive a response within 10 calendar days. In the unlikely event of an irresolvable complaint, it is possible for the matter to be carried to the N.C. Board of Massage & Bodywork Therapy, but only after every effort has been made to resolve the problem at NC Massage School.

GRADUATION

Graduation Requirements

Diplomas are awarded upon completion of the following:

- Meet all standards of progress outlined in the Satisfactory Progress and Attendance policy.
- Compliance with all rules and regulations of the school, including maintaining professional standards of conduct at all times.
- Tuition and fees paid in full or payment plan in place
- Any student who has not completed his/her graduation requirements, other than the regularly scheduled final massage practical, two weeks prior to the graduation date will not be allowed to participate in the official graduation ceremony.
- Students may participate in the graduation ceremony of the class in which they complete their work.
- Upon satisfactory completion of the program, you will receive a diploma which serves as professional certification. This program exceeds the recognized professional standard of 500 hours.

Upon satisfactory completion of the Neuromuscular Therapy program with a grade of 90 or higher on the final palpatory exam, you will receive a separate certification recognizing you as an advanced clinical bodyworker in structural dysfunction, soft tissue injury and chronic pain.



Licensure Requirements

North Carolina requires massage therapists and bodyworkers to be state licensed before they have the right to practice.

North Carolina requires graduates to pass the MBLEx exam as part of their application process. NC Massage School graduates are completely prepared to pass the exam.

Once a graduate successfully completes the MBLEx exam, they may then apply for state license.

Student Code of Ethics

Positive ethical behavior is expected of all students enrolled in NC Massage School program. Students must follow all school policies, which include but are not limited to:

- Students must dress modestly and appropriately while attending classes, following NC Massage School Student Dress Policy.
- Students must follow Attendance Policy.
- Students may not engage in any sexual activity on the campus.
- Sexual harassment or innuendoes are not allowable at any time at NC Massage School.
- Students must maintain acceptable personal hygiene.
- Smoking is not allowed inside the school building or on school grounds.
- Students may not violate the Substance Abuse Policy.
- Students must use professional draping procedures in all massage classes and clinics.
- Students may not cheat on exams or homework, or plagiarize
- Students may not be disruptive in classrooms or on school grounds and must treat instructors and fellow students with respect
- Students use of NC Massage School credentials and/or name before all graduation requirements are met is prohibited unless approved by the appropriate administrative staff.
- Students must respect the property of NC Massage School and obtain permission before using or taking any property owned by NC Massage School or by school personnel.
- Students must honor privacy and confidentiality of massage recipients, both student and public.

- Students must work with clinic clients in a professional and ethical manner and comply with all policies concerning the clinic experience
- Physical/verbal abuse is prohibited towards any instructor, staff member or student.
- Students must follow the Infectious Conditions Policy.
- Classroom behavior that could cause public comment that is detrimental to the profession is prohibited.
- Solicitation is not allowed at NC Massage School, either on school property or at any school-sponsored events.

Withdrawal Policy

Any applicant, withdrawing before or after acceptance to the program, must notify in writing his/her intent to the Administrator in a timely manner. After receipt of intention to withdraw, NC Massage School will forward a Withdrawal Form to be completed, signed and returned to the school. NC Massage School has 15 days to complete the withdrawal process after receipt of the Withdrawal Form. The result may mean a refund to the student or additional monies owed to the school. The following policy is designed to calculate the percentages for the withdrawal process.

- Termination Date: The termination date for refund computation purposes is the last date of actual attendance by the student.
- Rejection: An applicant rejected by the school shall be entitled to a refund of monies paid with the exception of the application fee and tuition deposit.
- Student Dismissal: For a dismissed student, refunded tuition will follow the same guidelines as for those students who withdraw.
- Right to Cancel: The applicant or student has the right to cancel and withdraw from the program at any time following the guidelines of the refund policy and enrollment contract

- Three-day Cancellation: All monies paid by the applicant will be refunded if requested within three business days after signing an enrollment contract and making initial payment with the exception of the application fee, and tuition deposit.
- Student Withdrawal: Any applicant subsequently requesting cancellation before entering school and starting the course, after signing the enrollment contract, and after three-day cancellation period, shall be entitled to a refund of all monies paid, less the tuition deposit and application fees.

Refunds

- For a student completing up to 5%, the tuition charge will be 5% of the contract price plus the tuition deposit and application fee.
- For a student completing more than 5% but no more than 10%, the tuition charge will be 20% of the contract price plus the tuition deposit and application fee.
- For a student completing more than 10% but no more than 25%, the tuition charge will be 50% of the contract price plus the tuition deposit and application fee.
- For a student completing more than 25% the student is responsible for 100% of the contract price. All unpaid payments will be paid to the school on pre-planned dates as contracted by the student.

Collection

In the event that a breach of contract or established agreement with the school occurs, the school reserves the right to refer all debt to a collection agency of their choice.

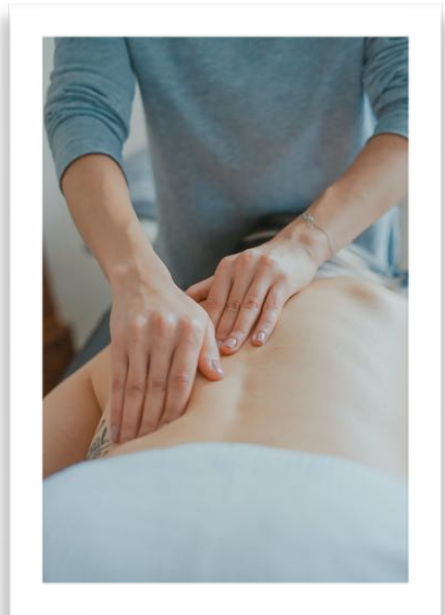
STUDENT SERVICES

Job Placement

NC Massage School supports graduates by passing along referrals on any job opportunities that become known to the school. NC Massage School encourages a variety of experiences and is aware that there are no guarantees of profitable employment. Library

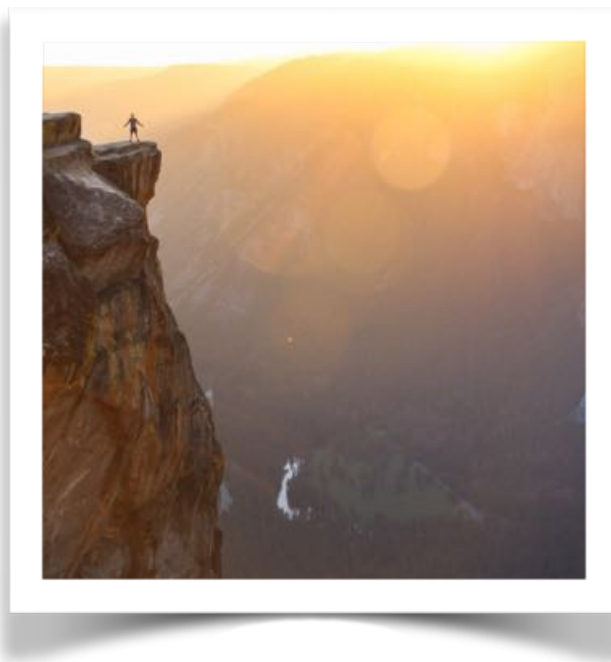

Student housing is not available at the school, however, the school keeps a listing of moderately priced rental facilities.

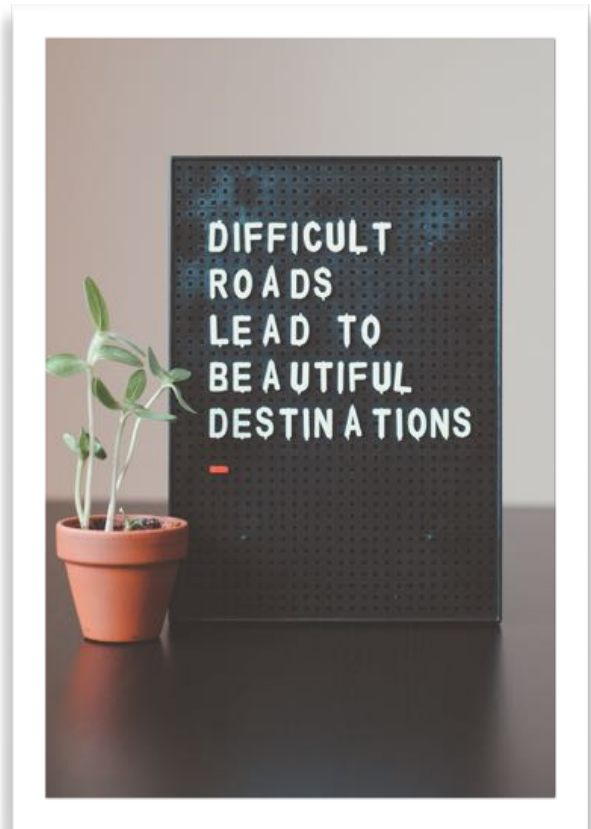
Student Records

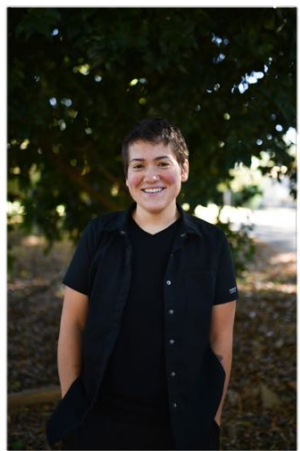

PAYMENT OPTIONS

Payment Terms for our Neuromuscular & Massage Therapy diploma program.

Tuition Payments:

- Non-refundable deposit of \$1,200.00 due upon acceptance.
- Tuition down payment of \$1,500.00 is due 4 weeks before the program begins.
- Balance of \$6,200.00 must be paid on or before the first day of class (unless financing).
- The total cost for tuition is \$8,925.
